### Pound I/I

Final design has been submitted to DEQ for their review and approval. We also had a call, last week with the US Fish and Wildlife service and the Army Corp of Engineers and the state division of wildlife resources and our consult team, and we hope that we can work on getting their requirements fulfilled to get a permit. We are moving ahead as planned

#### **Pound WWTP Upgrades**

The generator continues to be a topic of discussion. We had a call from the contractor, they offered us a \$50,000 credit and repair of the damaged panels to keep the damaged generator. We counteroffered a 5 year warranty with an additional 5 years and a rigorous start up test for at least 12 hours to make sure it runs as it should. We have also requested they include a repair of a broken conduit and valve. We are waiting to hear back if that is accepted to present to the board

#### Banner Sewer

We had a meeting with the town of Coeburn last week. We hope to bid once we get the green light

#### **Pound Water Treatment Plant Improvements**

We are getting ready to readvertise the tank portion of the project. We have some additional funds to get the tank constructed so we hope to get the advertisement published within the next two weeks.
