## **PROJECT UPDATES**

Director Cody McElroy submitted project updates on behalf of T&L.

### **Hamilton Town Sewer Extension**

The final paving is being done this week. Project should be closing out at the end of July. Everyone is connected to the sewer. Some clean up still has to be done.

# Lower Bold Camp

The contractor will be finishing as much work as they can through the rest of this week and possibly next week. With the time restriction due to the Big Sandy Cray Fish, they will be pulling off the site until mid-September.

#### **Pound WWTP Upgrades**

Mobilized yesterday, July 10<sup>th</sup>. The demolition sub-contractor is on site to begin tearing down the old drying beds and putting the new press building up in the next month or so. This project will most likely stop and start back up later on due to the wait times on the electrical equipment. The generator for the plant is anticipated to be delivered September 2024.

#### Pound I/I Projects

This is still in design. We anticipate the first round of preliminary review to be done in mid-August.

Director Cody McElroy submitted project updates on behalf of The Lane Group.

#### Banner Sewer

We have made the applications and requests for funds from DHCD. We are working with

lenwisco and the county administrators office, in August the Board of Supervisors should see some resolutions for the funding application for additional funds. We are still working on meeting with Coeburn.

### Pound System-Wide Improvements 2023

We have a meeting on Friday, July 14<sup>th</sup>, with the Health Department. The following week we plan to start reviewing the preliminary design.

### Pound Water Treatment Plant Improvements

This should be submitted to the Health Department in the next couple of weeks. They are wrapping up a few things on the electrical design.

# Pound River Interceptor

This project is almost complete in design. We are waiting on the environmental report to come back. The surveys were done in June and Big Sandy Cray Fish were found as we anticipated. Once we get the environmental report back we will start applying for permits and other things necessary to start the work. We will also be working on acquiring easements which we have counted 101 so far that are needed for this project.

### St. Paul Interconnect Study

We met on this last week and got some information from Russell County for what they may need in the future. We should start seeing the report in the next 30-60 days.

#### Bear Creek Community Water

There is a recommendation for the bid that we opened for this project last month.

# Appy Elementary STP

We are still waiting for the MOU to be signed by Mountain Empire, the county, and the PSA. We don't have any updated on that right now. We are also meeting to discuss the demolition but the new tanks are here as well as the electrical equipment.

# High Knob Rec Area Sewer

A year or so ago we redone the water and now we have been working with the Forest Service. They have received about \$7,500.00 in a grant. We will be working with them on a new septic/holding tank at the bath house. This will be something that would be pumped instead of doing an entirely new sewer system. We would pump and haul of the waste for them.
