Director Cody McElroy submitted project updates on behalf of T&L.

Hamilton Town Sewer Extension

Construction has begun and about half of the sewer line has been installed.

Lower Bold Camp

The agreements and first change order have been signed to get the project cost reduced from \$1.9 million to \$1.6 million. Waiting on bonds and insurance so a preconstruction conference can be scheduled.

Pound WWTP Upgrades

The contract was received March 14th and needs to be signed and will be delivered back to the engineer so that the project can begin.

Banner Sewer

Project did not receive ARPA funds from DEQ that were applied for.

Upper Guest River Sewer Phase 1

Project did not receive ARPA funds from DEQ that were applied for.

Glamorgan Sewer

Received the requested \$300,000 ARPA funds.

Pound River Interceptor

Preliminary design is underway. Some survey work will be completed next week for some of the side lines that tie into the interceptor. Hopefully the Environmental Plan will be submitted soon.

Director Cody McElroy submitted project updates for PSA

Bear Creek Community Water

Waiting on the funding contract to be finalized with the County and DHCD for the ARC grant funds. This should happen within the next month. The in-house plans have been submitted to the Health Department for their review. Project should be able to advertise in the summer. This project is 11 connections.

Family Crisis Utilities

The water system is complete. The sewer system will begin next week which will be run from the bottom of the hill where Quality Carpet is and then up the side of the hill to the top where the shelter is going. Construction should be completed within the next 60 days.

Private Drive Service: 1st can - \$30, each additional can \$15 per month Additional dumpster collection: \$25 per occurrence outside normal schedule We will begin working to confirm our user agreement has the appropriate language with the PSA attorney and begin marketing the new service.
