Carfax

We finally received comments back from the Health Department on the biddability review. They had some recommended/required changes on the bid documents regarding some new federal language on some of the items and clarifications. We are submitting this back to them this week.

We are going to advertise this project this weekend, after beginning this project in 2017.

Pound System-Wide Improvements 2023

Tanks have been ordered, and we are waiting for the pre-construction for that. We have a meeting on the 22nd of July for the water plant to get that back on track with some redesign.

They are still working on designs and surveys for this and hopefully we will have a late fall advertisement for this project.
